



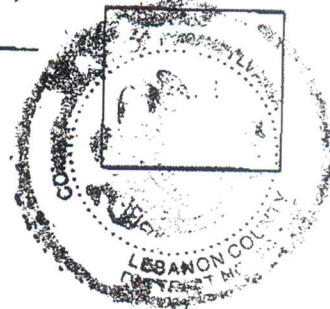

POLICE CRIMINAL COMPLAINT**AFFIDAVIT of PROBABLE CAUSE**

Your Affiant, Gordon R. Goodrow, is a Supervisory Special Agent with the Pennsylvania Office of Attorney General's Child Predator Unit. Your Affiant is assigned to the Internet Crimes Against Children (ICAC) Task Force which is comprised of Federal, State, and Local Law Enforcement. The task force is responsible for conducting undercover online investigations, responding to complaints regarding children sexually exploited via the Internet, conducting community education programs and monitoring of the Internet for the bartering in child pornography. Your Affiant has been investigating Internet Crimes against Children since 1999. Before being employed as a Special Agent with the Pennsylvania Office of Attorney General, your Affiant was employed as a Police Officer/Detective at the Lower Paxton Police Department in Harrisburg, PA., from September of 1986 until January of 2012. Your Affiant has attended multiple training courses that focused on Internet Crimes against Children, including computer-based offenses.

Parts of your Affiant's duties include investigating violations of state law, such as the online exploitation of children. In particular, violations of Title 18, Section 6312, that criminalizes the possession, receipt, and transmission of child pornography. Your Affiant has gained experience conducting such investigations through training seminars, classes and consistent work assignments.

On March 04, 2019, Case #56-2590 was opened regarding the receipt of NCMEC CT #46325133. On February 05, 2019, the National Center for Missing and Exploited Children (NCMEC) received a complaint from the electronic service provider Tumblr. Tumblr reported at least one image containing suspected child pornography was uploaded on Thursday, December 28, 2017 at 22:36:34 -500. Tumblr provided the following information regarding the reported suspect who uploaded the aforementioned image:

I viewed the above listed file, and confirmed that the file appeared to depict a child, under the age of eighteen (18) years old engaged in sexual acts and/or pose, and is believed to be child pornography in violation of Pennsylvania Crimes Code Section 6312 - Sexual Abuse of Children.

Below is a brief description of the sexually explicit file in question which was reported by Tumblr:

1. **File Name:** 168880208675_o1_legacy_photo.png

Description: This color image depicts a very young female child performing fellatio on an adult male. The adult male is lying on his back with his pants unzipped, his erect penis exposed. The child has long blonde hair with bangs across her forehead and she is wearing a pink shirt. The child is lying between the adult's legs and has the adult's penis in her mouth.

A check of publicly available records located online by an organization known as MAXMIND, determined that the suspect IP address 75.75.133.18 was assigned to a company known as Comcast Cable.

On March 05, 2019, I de-conflicted in the Internet Crimes Against Children (ICAC) Cops data base. The ICAC Cops database is an online portal to assist ICAC taskforce members in their child exploitation investigations. On this date, I discovered that no other ICAC task force members were investigating the IP address, the Infohash, online identity, or the Tumblr URL.

Michael Folmer drove himself back to his residence.

SA Trac Huyhn of the Department of Homeland Security and your Affiant spoke with Michael Folmer, advising him of the purpose of the search warrant. Prior to asking any questions related to the investigation, Michael Folmer was advised of his Miranda Rights, to which he stated he understood and was willing to speak with agents without the presence of an attorney.

Your Affiant advised Michael Folmer about the nature of the investigation. During the interview, Michael Folmer admitted that the Tumblr account associated with the CyberTip was indeed his along with the identified email, jaymichael143@yahoo.com. Michael Folmer stated that he had been dealing with some personal problems/issues and that he had received child pornography through his Tumblr blog.

On 09.17.2019, a sealed search warrant was obtained through the Court of Common Pleas of Lebanon County. The search warrant was obtained to search the cell phone of Michael Folmer that was recovered by SA Deeter. The cell phone was identified as an Apple iPhone 8 Plus, Model #MQ8W2LL/A, Serial #FD8Y503PJCLQ. During a computer forensics search of the phone two (2) images of apparent child pornography were discovered. The two images discovered depicted indecent contact with a minor.
