**JOINT APPLICATION FOR RELIEF IN THE
NATURE OF A MOTION TO CONTINUE ORAL ARGUMENT**

The parties, through their undersigned counsel, pursuant to Rule 123 of the Pennsylvania Rules of Appellate Procedure, hereby submit this Joint Application for Relief in the nature of a motion to continue oral argument, and in support thereof aver as follows:

1. Petitioner commenced this action on July 22, 2020 with the filing of a Petition for Review.
2. The same day, Petitioner filed an Emergency Application for Relief and Expedited Hearing.
3. Respondent filed an Answer to the Emergency Application on July 29, 2020.

4. Oral argument on the Emergency Application was scheduled for July 30, 2020, but at the request of the parties was continued to August 10, 2020.

5. The parties have now reached an agreement in principle to resolve this case but require additional time to obtain the necessary signatures on the written agreement.

6. Accordingly, the parties jointly request that the Court continue the August 10, 2020, oral argument to allow the parties time to finalize the documents.
